- 1. Call to Order
- 6:44 called to order by Brittany, seconded by Leanne
- 2. Additions to Agenda
- Discussion of Points

It used to be 5 of 7 shows, now it's 6 shows total

As of last Directors' meeting, voted in that every show will be worth even points

Discussion regarding "best of three" (or four), as opposed to someone who went to all the shows and did poorly, but could still be year-end champion – does this discourage participation?

Discussion re: horse/rider combination rule changes – is this such an issue now that we have scrapped double points? Overall opinions of membership: no, even points addresses the issue

Member question: why are the points different in the medals? Does it need to be reviewed, if we're trying to encourage participation? Diana: medals are not a division, they are individual classes. Meghan: Medals are also individually sponsored classes, so the sponsor chooses the criteria.

Leanne: rules changes review:

Short/Long Stirrup Divisions, Beginner Hunter will be judged on rider, points accrued by rider

Jumping points stay the same

Flat – 5,3,2,1 (no half points)

Hunters 2'6" and up – points accrued by the horse

Still looking for a sponsor for one Medal Class – any ideas among membership?

Member question: Vast inconsistency in the prizes at SSITS – some divisions got incredible prizes, some divisions almost nothing - can we ensure that there is some level of consistency?

Board: Not much we can do on a show that isn't run by the VIHJA, other than give feedback to the management of the show, also, we are working with individual sponsors who may choose to sponsor very differently

Brittany: Could we send out a suggested monetary value for Champion, Reserve, etc? To help with consistency across different shows

Approval of minutes suggested by Brittany, seconded by Meghan

- 4. Financials
- Benefits show around \$8000 profit (about double from last year)
- Hunt Ball lost about \$3000 in 2016, last year made \$3000 (in the plus for the first time ever)
- Conflict with Appy Show

Brittany: spent a fair money on jumps this year, as planned – Hunter boxes etc

GIC of \$15,000 available if needed for Benefit Show this year

Member: question re: balance sheet, can be made available by accountant

Member: do we have all the jumps we want/need? M/B: no, poles are next priority, then replace standards

Member: are the assets of the club not recognized on the financials? eg. Value of jumps

Leanna: Mitch has been hired to do an inventory to place values of everything, so this is pending

Member (Cathy) – historically we have written them off as soon as they are purchased, rather than running a depreciating value
